I am directed to forward herewith the following 03 scholarship schemes for all eligible trainces of Govt. managed institutes (ITIs), BTC, MSDP, Extension Centre DTTE duly approved by competent authority, for the trainees of Engineering/Non-Engineering Trades /Courses of One year/Two years duration (both NCVT and SCVT) along with the eligibility criteria, rate and selection procedure.

- (i) Topper's Scholarship (erstwhile *Merit Scholarship, DGT)
- (ii) Merit Scholarship
- (iii) Merit cum means Scholarship

Scholarship Schemes in Industrial Training Institutes (ITIs)

Background & Objective: Department of Training & Technical Education has continued its endeavour towards the welfare of the students of Industrial Training Institutes (ITIs) by providing financial aid by means of following scholarship scheme so that they can complete their training without any hurdle. Further, scholarship will also encourage parents of economically weaker section/minorities communities to send their wards to Industrial training institutes to acquire for jobs/self-employment. The scholarship schemes also forms the foundation for their skill enhancement and provides a level playing field in the competitive employment arena. Empowerment through Skill is one of the objectives of the scheme which in turn lead/upliftment the socio economic conditions of the economically weaker section/minorities communities.

- (i) Topper's Scholarship (erstwhile "Merit Scholarship, DGT)
- (ii) Merit Scholarship
- (iii) Merit cum means Scholarship

Scope: The scholarship scheme is open to all eligible trainees of Government managed Industrial training Institutes (ITIs) for all Engineering/Non Engineering, One Year/Two Year Duration courses in a transparent manner by the state fund of Government of National capital territory of Delhi through Department of Training & Technical Education. However, privately

managed Institutes/ Institutes managed by other Government Department may be welcomed if they adopt the scheme with its letter and spirit.

Eligibility: The eligibility criteria of each scheme with the capping of marks and annual income of their parents/guardian from all sources are tabulated below.

Selection Procedure: As the number of scholarships are fixed and limited. it is necessary to lay down the preference for selection. The list of beneficiaries shall be prepared by committee members constituted for the purpose.

- 1. Internal test (Trade Practical & Trade Theory (Objective type)) shall be conducted at institute level for Topper's Scholarship keeping in mind that at least one trainee should get Trade Topper's Scholarship. Whereas balance scholarship will be decided by the committee member constituted for the purpose on the basis of merit and allied criteria.
- 2. Inter-se selection weight-age is to be given to poverty rather than marks (As per 1 from "Date of Range 2 of 4 applicant Income certificate).
- 3. In case of same income, merit shall be generated from "Date of Birth" criteria of

applicant (senior is preferred).

4. For the trainees of second year of Two year duration courses the criteria of 90% marks in first year of 02 year duration courses must be satisfied.

Duration: The disbursement of scholarship shall be limited to 10 months in an academic year for Day scholar.

Implementing Agencies: The scholarship scheme is implemented by Govt of NCT Delhi, through Department of training & Technical Education.

Conditions of Scholarship:

- 1. Scholarship will be available to all trainees of 1 year and 02 year duration courses (both NCVT & SCVT).
- 2. An income certificate, issued from a competent authority in the State/UT Government in respect of Parent/Guardian of the student.
- 3. For the trainees of one year duration, First year/second year of Two year duration courses the criteria marks must be satisfied.
- 4. Scholarship will not be given to more than two trainees of same family.
- 5. Trainees should be regular in attendance for which DGT minimum attendance criteria will be considered as yardstick.
- 6. The claim of trainee will be decided by institute on the basis of records available in the institute.
- 7. If trainees violate institute discipline or any other terms and conditions of the scholarship, scholarship may be suspended or cancelled.
- 8. If a trainee is found to have obtained a scholarship by false statement or concealing facts his/her scholarship may be cancelled forthwith.
- 9. All scholarship shall be credited to trainees Aadhaar seeded bank account directly under Direct Benefit Transfer (DBT) Mode. Since the process of digitization i.e. on boarding of scholarship to DBT platform is on the way till than ECS may be considered.
- 10. The Trainees shall be eligible for only one scholarship out of the entire available scholarships scheme.
- 11. It will be necessary for all eligible applicants to have Aadhaar number. For alternative document till the Aadhaar enrolment made Gazette Notification Dated 21.4.2017 may be considered

12. The process of on boarding of scholarship on NSP platform is under way separate guidelines shall be issued in this regard.

Finance/Budget: The scholarship schemes are 100% funded through consolidated fund of GNCTD.

Monitoring & Transparency: Every institute shall maintain year wise details of the trainees receiving scholarship and must share the same to Nodal Officer (Scholarship), DTTE (HQ.)
